Effective January 1, 2004, a manuscript whose corresponding author is a member of the Biophysical Society at the time of original submission is subject to a reduced \$50 per page fee for pages 1-8, \$100/page for pages 9-11, and \$200/page for pages 12 and over. Page charges for nonmembers are \$70 per page for pages 1-8, \$100/page for pages 9-11, and \$200/page for pages 12 and above.

All authors are expected to pay the page charges for articles they publish in *Biophysical Journal*. Failure to honor page charge obligations may affect future manuscript submissions.

Biophysical Letters: Authors who publish Biophysical Letters will be responsible for a \$500 page charge for printing no more than three published pages.

Page Proofs: If paper is accepted, authors will be granted up to an average of two corrections per page at no cost. Any corrections made to the proofs which exceed two per page will be charged to the author at a rate of \$4.00 per correction. Any figures that are replaced through no fault of the Journal Office or the Printer will also be charged to the author.

*Color figures that in the estimation of referees and the Editorial Board significantly enhance a paper will be printed free of charge to its authors, provided the corresponding author of the paper in question is a current member of the Biophysical Society at the time of the first submission of the original manuscript.
